3 **ARTICLE 16**
4 **ARBITRATION**
5

6 **Section 1.** If the grievance brought under Article 15, Grievance Procedure is not resolved
7 at Step 3, the Union may submit the matter to arbitration.
8

9 **Section 2.** Notice of intent to arbitrate must be filed with the Provost within 21 days of
10 date of issuance of the Step 3 decision.
11

12 **Section 3.** Within 40 days of receipt of the notice of intent to arbitrate, the parties shall
13 meet to attempt to agree upon an arbitrator. If the parties are unable to agree upon an
14 arbitrator within 5 days of the meeting, the party initiating arbitration shall request the
15 Oregon Employment Relations Board to submit a list of five arbitrators with experience
16 in higher education faculty employment cases, none of whom shall be an employee of the
17 University, the Union, the AFL-CIO, the AFT, the AAUP or any other labor organization
18 unless both parties agree otherwise in writing. The arbitrator shall be or shall have been a
19 practicing attorney.
20

21 Each party shall alternately strike one name from the list of five. The parties will flip a
22 coin to decide which party strikes first. The last remaining person on the list shall be
23 selected as the arbitrator.
24

25 If the arbitrator selected cannot hold the hearing within 90 days and either party does not
26 agree to an extension, a new list of 5 names shall be requested from the Oregon
27 Employment Relations Board and the selection procedure shall be repeated.
28

29 **Section 4.** At least 10 days in advance of the scheduled hearing, the parties shall meet to
30 draft a submission agreement. They shall attempt to agree on the precise issue to be
31 submitted to arbitration, a stipulation of facts, joint exhibits and any other matter
32 designed to expedite the arbitration process.
33

34 If the parties are unable to agree on the precise issue to be submitted, each party shall
35 submit its own version of the issue and the arbitrator shall decide the precise issue to be
36 arbitrated.
37

38 **Section 5.** The arbitrator shall hold the hearing in Eugene, Oregon unless otherwise
39 agreed in writing by the parties. The hearing shall be held without unreasonable delay
40 upon the arbitrator's acceptance of the case, but in no case less than 30 days or more than
41 90 days from the arbitrator's acceptance of the case, unless the parties agree in writing
42 otherwise.
43

1 If the arbitrator or either party requests that post-hearing briefs be submitted, the
2 arbitrator shall establish a date for the submission of such briefs and the record will be
3 deemed to have been closed as of such date.

4
5 **Section 6.** In a proceeding under this Article for which there is a submission agreement,
6 the first matter to be decided is the arbitrator's jurisdiction to act. If arbitrability is in
7 dispute, the arbitrator shall hear the parties on the question and may take whatever
8 evidence he or she finds relevant and necessary before determining arbitrability. Upon
9 concluding that the issue is arbitrable, the arbitrator shall proceed with the case, with each
10 party retaining the right to seek judicial review of the arbitrator's decision as to
11 jurisdiction. Upon concluding that the arbitrator has no jurisdiction, the arbitrator shall
12 not hear the matter or make any decision or recommendation regarding the merits of the
13 case.

14
15 In the absence of a submission agreement, the arbitrator shall first decide the issue to be
16 arbitrated, and then the question of the arbitrator's jurisdiction.

17
18 **Section 7.** The arbitrator derives authority wholly and exclusively from this Agreement.
19 The arbitrator shall not add to, subtract from, modify, or alter the terms or provisions of
20 this Agreement.

21
22 Except as otherwise provided in this Agreement, the arbitrator shall have no authority to
23 hear or decide any issue or grievance relating to any academic judgment. In cases
24 involving academic judgment, the arbitrator shall not substitute his or her judgment for
25 that of the University, nor shall the arbitrator review such decision except for the purpose
26 of determining whether the procedural steps provided in this Agreement have been
27 followed. If the arbitrator determines that procedural steps have not been followed where
28 an exercise of academic judgment is involved, the arbitrator shall direct that the matter be
29 reconsidered by the appropriate decision maker in accordance with relevant procedural
30 steps. Under no circumstances may an arbitrator direct that a bargaining unit member be
31 appointed, reappointed, reinstated, promoted or awarded tenure.

32
33 The arbitrator shall have no authority: (a) to award monetary damages, fines or penalties,
34 except for back pay or benefits; (b) to make a decision limiting or interfering in any way
35 with the powers, duties, or responsibilities of the University which have not been
36 expressly limited by this Agreement; or (c) to consider the discipline of members of
37 another bargaining unit or other University employees who are not members of the
38 bargaining unit represented by this Union in rendering a decision.

39
40 **Section 7.** The arbitrator shall issue a decision within 30 days of the close of the hearing
41 unless the parties have agreed to additional time. The decision of the arbitrator shall be in
42 writing and shall set forth findings of fact, reasoning and conclusions on the issues
43 submitted. The decision of the arbitrator shall be final and binding upon the parties as to

1 the issues submitted, provided that either party may seek judicial review of the decision
2 as provided by law.

3
4 **Section 8.** All fees and expenses of the arbitrator shall be paid by the party not prevailing
5 in the matter.

6
7 Each party shall bear the cost of preparing and presenting its own case. Expenses of
8 witnesses, if any, shall be borne by the party calling the witness. The costs of any
9 transcripts of the hearing required by the arbitrator shall be divided equally between the
10 parties and each party will be furnished a copy. If either party wishes a transcript of the
11 hearing, it may have one made at its own expense and shall be under no obligation to
12 provide the arbitrator or the other party with a copy.

13
14 **Section 9.** The compensation of any bargaining unit faculty member called as a witness
15 and/or serving as the Union representative in an arbitration hearing shall not be reduced
16 for a reasonable period of time to prepare for and to give testimony at the hearing, or in
17 the case of the Union representative, to represent the Union at the hearing. Every effort
18 shall be made to avoid unduly disrupting the work of any bargaining unit faculty member
19 called to serve as a witness.
